 - (1) The securities were disposed of pursuant to a merger agreement between the issuer and Packers Service Group, Inc. ("Packers") whereby Packers was merged with and into a wholly owned subsidiary of the issuer (the "Merger") in exchange for the issuance to the shareholders of Packers of a total of 10,594,181 shares of the issuer's Class A common stock having a closing market price of \$25.47 per share on the effective date of the Merger.
 - (2) The reporting person disclaims beneficial ownership of these securities except to the extent of his pecuniary interest in the holder thereof, and this report shall not be deemed an admission that the reporting person is the beneficial owner of such securities for purposes of Section 16 or for any other purpose.
 - (3) The securities were received in exchange for shares of capital stock of Packers, a privately held company, in connection with the Merger. The shares of the issuer's Class A common stock received in the Merger had a closing market price of \$25.47 per share on the effective date of the Merger.
