Each phantom stock unit entitles the reporting person to a cash payment based on the value on the payout date of the issuer's common stock corresponding to such units. Based on the \$104.58 closing price of the issuer's common stock on the transaction date, each unit corresponds to approximately 2.68 shares.
- (2) The reporting person may transfer these phantom stock units to alternative investment funds in the Plan beginning three years from transaction date.
- (3) Phantom stock units are settled in cash after the reporting person ceases to be a member of the issuer's board of directors.
