(1) On August 5, 2011, Sunstone Hotel Investors, Inc. (the "Company") granted 327,225 restricted shares of common stock to the Reporting Person pursuant to its 2004 Long-Term Incentive Plan of which i) 60% of the shares are subject to the satisfaction of time-based, pro-rata vesting requirements over a five-year period with the initial vesting to occur on the third anniversary of the grant date and ii) 40% of the shares are subject to performance-based, cliff-vesting on the fifth anniversary of the grant date.
