Long-term incentive plan units ("LTIP Units") in Douglas Emmett Properties, LP, a DE limited partnership (the "Operating Partnership"). Issuer is the sole stockholder of the general partner of the Operating Partnership. LTIP Units have full parity with partnership common units (the "OP Units") for all purposes and subject to vesting, may be converted into an equal number of OP Units on a one-for-one basis.
- (2) Upon the occurrence of certain events, LTIP Units and OP Units are redeemable, without consideration, for an equivalent number of shares of Issuer's common stock or for the cash value of such shares, at Issuer's election.
- (3) LTIP Units vest one-half on January 13, 2012, with the remainder vesting one-third on each December 31 of 2012, 2013 and 2014.
- (4) Not applicable.
- (5) Reporting Person also owns 210,385 partially vested LTIP Units granted January 18, 2011, 177,830 partially vested LTIP Units granted December 2, 2010, 36,914 partially vested LTIP Units granted January 19, 2010, and 27,364 vested LTIP Units granted January 12, 2009.
