(1) The grant of Restricted Stock Units (RSUs) reported herein, entitles the Reporting Person to the receipt of shares of the issuer's common stock in equal installments of one-third of the original RSU grant on either (i) the annual vesting of the grant or (ii) upon the conclusion of such longer deferral period as the Reporting Person may elect in advance. In either occurrence, (i) or (ii), the RSUs automatically convert into shares of common stock on a one-for-one basis at no conversion cost to the Reporting Person.

(2) The options cliff vest 100% three years from award date on 08/29/14. The options convert into shares of common stock on a one-for-one basis.
