- The sales were effected pursuant to a Rule 10b5-1 trading plan. 98,371 shares were sold on AMEX and a total of 35,000 shares were sold on the TSX. The sales took place within 6 months of the acquisition by the reporting person of 2,400,000 units, each consisting of one (1) share and one-half warrant of the issuer, on July 24, 2008, at a price of \$0.49 per unit. No short-swing profits were realized in respect of these sales under section 16(b) of the Exchange Act, based on the market price of Apollo Gold stock on July 24, 2008 of \$0.40 per share (as required under Exchange Act Rule 16b-6).
