Unilever NV announces that on 11 April 2007 it purchased 350,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at a price of euro 22.045 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 199,665 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 58,130,029 Unilever NV ordinary shares in treasury, and has 1,656,597,671 Unilever NV ordinary shares in issue (excluding treasury shares).
