Unilever NV also announces that 52,497 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 70,718,927 Unilever NV ordinary shares in treasury, and has 1,644,008,773 Unilever NV ordinary shares in issue (excluding treasury shares).
