Unilever NV announces that on 20 March 2008 it purchased 591,688 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 20.780 and euro 21.410 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 873,796 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 149,261,898 Unilever NV ordinary shares in treasury, and has 1,565,465,802 Unilever NV ordinary shares in issue (excluding treasury shares).
