REGISTRATION OF ADDITIONAL SHARES

This Registration Statement on Form S-8 registers 1,000,000 additional shares of the common stock, par value \$0.01 per share (the Common Stock), of Insmmed Incorporated (the Company or the Registrant) which may be acquired pursuant to the Registrant's Amended and Restated 2000 Employee Stock Purchase Plan (the Plan). The securities subject to this Registration Statement are of the same class of the Registrant for which the Registrant previously filed Registration Statements on Form S-8 under the Securities Act of 1933, as amended. Accordingly, the contents of the Registrant's Registration Statement on Form S-8, File No. 333-39198, as filed with the Securities and Exchange Commission (the Commission) on June 13, 2000, and on Form S-8, File No. 333-129479, as filed with the Commission on November 4, 2005, is hereby incorporated by reference pursuant to General Instruction E to Form S-8. After giving effect to this Registration Statement, an aggregate of 1,500,000 shares of the Registrant's Common Stock have been registered for issuance pursuant to the Plan.
