By letter dated November 14, 2007, the Company reported that several holders of the Company s Convertible Notes exercised their conversion rights. Hence, the financial indebtedness of the Company shall be reduced in US\$ 802,807 and accordingly, a capital increase of 1,473,030 ordinary shares face value pesos 1 each has been made. The conversion was performed according to the terms and conditions established in the prospectus of issuance at the conversion rate of 1.83486 shares, face value pesos 1 per Convertible Note of face value US\$ 1. As a result of that conversion the amount of shares of the Company goes from 575,705,588 to 577,178,618. As the exercise period for the Company s Convertible Notes has expired, as of this date the Company will proceed to pay the outstanding amount of US\$ 57,657.
