On November 29, 2010 CDW Corporation (the Company) reported that total net sales (unaudited) for the ten months ended October 31, 2010 increased \$1,416.7 million, or 24.1%, to \$7,305.4 million, compared to \$5,888.7 million for the same period in 2009, reflecting strong continued growth across all of the Company's customer channels.
