**Item 8.01. Other Events.**

On May 20, 2011, Exelon Corporation (Exelon) and Constellation Energy Group, Inc. (Constellation) filed an application for approval by the Federal Energy Regulatory Commission (FERC) of the proposed merger announced by the companies on April 28, 2011. A copy of the FERC filing is available on the merger website, [www.exelonconstellationmerger.com](http://www.exelonconstellationmerger.com), and will also be available on the FERC website, [www.ferc.gov](http://www.ferc.gov).

In addition, Exelon and Constellation have made other filings in support of their proposed merger, including with the Nuclear Regulatory Commission, the New York State Public Service Commission and the Public Utility Commission of Texas. The companies will also be filing with the Maryland Public Service Commission and other regulatory bodies.

A copy of the press release concerning the regulatory filings is attached as Exhibit 99.1.
