On September 9, 2011, Cumulus Media Inc. ( Cumulus Media ) and Citadel Broadcasting Corporation ( Citadel ) issued a joint press release (the Press Release ) announcing an extension of the deadline for holders of Citadel common stock or warrants to purchase Citadel common stock to deliver their election forms to elect the form of consideration they wish to receive in the previously announced merger of a subsidiary of Cumulus Media with and into Citadel, pursuant to which Citadel will become an indirect wholly-owned subsidiary of Cumulus Media (the Merger ), to U.S. Bank National Association, as exchange agent for the Merger.
