**ITEM 2.01. Completion of Acquisition or Disposition of Assets.**

On August 15, 2012, STERIS Corporation ( "STERIS" ) completed the previously announced acquisition of all the outstanding shares of capital stock of United States Endoscopy Group, Inc. ( "US Endoscopy" ) pursuant to that certain Stock Purchase Agreement (the "Stock Purchase Agreement" ) dated July 16, 2012 with US Endoscopy and its shareholders. The purchase price was \$270 million, subject to a customary working capital adjustment. In addition, STERIS purchased all real estate used in the US Endoscopy business for approximately \$7 million, including properties owned by two US Endoscopy affiliates. STERIS did not assume any existing debt in connection with the purchases. The purchases were financed by a combination of cash on hand and borrowings under STERIS' s existing credit facility. The shareholders of US Endoscopy were various trusts of Marlin E. Younker family members and are more specifically identified in the Share Purchase Agreement. The US Endoscopy affiliates selling real estate were My Land Holdings, LLC and Pa's Kids, LLC.

The foregoing description does not purport to be complete and is qualified in its entirety by reference to the Stock Purchase Agreement. A copy of the Stock Purchase Agreement is filed herewith as Exhibit 2.1 and is incorporated herein by reference.
