### **Introductory Statement**

This Issuer Tender Offer Statement on Schedule TO relates to an offer by The Central Europe, Russia and Turkey Fund, Inc., a non-diversified, closed-end management investment company incorporated under the laws of the State of Maryland (the Fund), to repurchase for cash up to 566,397 of the Fund's issued and outstanding shares of common stock, par value \$0.001 per share, upon the terms and subject to the conditions contained in the Offer to Repurchase, dated February 14, 2014, and the related Letter of Transmittal (which, together with any amendments or supplements thereto, collectively constitute the Offer to Repurchase), which are filed as exhibits to this Schedule TO. The price to be paid for the shares is an amount equal to 98% of the Fund's net asset value (NAV) per share (that is, the value of the Fund's assets minus its liabilities, divided by the number of shares outstanding) as determined by the Fund on the next business day following the expiration date of the tender offer, or such later date to which the offer is extended. The Fund normally calculates its NAV per share at 11:30 a.m. New York time on each day that the New York Stock Exchange is open for trading.
