As previously announced, on July 29, 2015, Fifth Third Bancorp (Fifth Third) entered into an accelerated share repurchase transaction with Morgan Stanley & Co. LLC (Morgan Stanley) pursuant to which Fifth Third would purchase approximately \$150 million of its outstanding common stock. Fifth Third is repurchasing the shares of its common stock as part of its 100 million share repurchase program, previously announced on March 18, 2014.

On September 1, 2015, Fifth Third was notified by Morgan Stanley that effective Monday, August 31, 2015, they had finished purchasing shares under the July 29th agreement. A total of 6,039,792 shares were repurchased upon execution of the agreement, and an additional 1,346,314 shares were repurchased upon completion of the agreement. The additional shares are expected to settle on Thursday, September 3, 2015. In total, 7,386,106 shares were repurchased under the July 29th agreement, at an average price of \$20.3084.

After the completion of the July 29th agreement, Fifth Third had approximately 47.8 million shares of remaining repurchase authority under its share repurchase program previously announced on March 18, 2014.

Morgan Stanley and certain of its affiliates have performed, and in the future may perform, various financial advisory and other services for Fifth Third and Fifth Third s affiliates for which they have received, and may in the future receive, customary fees and expenses.
