FP GP LLC is the general partner of FP I and FPFA. FPM LP is the manager of FPAFI. FP GP III LP is the general partner of FP III and FPPF III, and FP GP III Mgmt is the general partner of FP GP III LP. The managers of FP GP LLC have the power, acting by majority vote, to vote or dispose of the shares held directly by FP I and FPFA. The managers of FP GP III Mgmt have the power, acting by majority vote, to vote or dispose of the shares held directly by FP III and FPPF III. The partners of FPM LP have the power, acting by majority vote, to vote or dispose of the shares held directly by FPAFI. As a result of these relationships, each of FP GP LLC, FP GP III LP, FP GP III Mgmt and FPM LP has shared voting and dispositive power with respect to the shares of Common Stock directly held by FP I, FPFA, FPAFI, FP III and FPPF III.
