Alan Trefter is the beneficial owner of 39,482,248 shares of Common Stock which includes 118,000 shares held by the Trefter Foundation, of which Mr. Trefter is a trustee. Mr. Trefter has no pecuniary interest in the 118,000 shares of Pegasystems Inc. stock which are held by the Trefter Foundation. Mr. Trefter retains voting and dispositive control over such shares.
