Linked to the Russell 2000® Index

The payment at maturity will reflect the following terms:

#### o If the level of the Index increases (regardless of the extent of that increase) or stays the same:

You will receive the original offering price plus a contingent fixed return of 28% of the original offering price

#### o If the level of the Index decreases but the decrease is not more than 35%:

You will be repaid the original offering price

#### o If the level of the Index decreases by more than 35%:

You will have full downside exposure to the decrease in the level of the Index from the starting level, and you will lose more than 35%, and possibly all, of the original offering price of your securities

Investors may lose some, or all, of the original offering price

How the redemption amount is calculated

The redemption amount payable at maturity will be determined as follows:

If the ending level is greater than or equal to the starting level, the redemption amount will be equal to \$1,000 *plus* the contingent fixed return

If the ending level is less than the starting level, but greater than or equal to the threshold level, the redemption amount will be equal to \$1,000

If the ending level is less than the threshold level, the redemption amount will be equal to \$1,000 minus

\$1,000 × starting level ending level starting level

If the ending level is less than the threshold level, you will lose more than 35%, and possibly all, of the original offering price of your securities at maturity.
