(1) Gift

1,625,817 shares were transferred from the Dauch Annuity Trust 2004 to the Sandra J. Dauch Gift Trust dated May 25, 1998, an irrevocable trust established by the reporting person for the benefit of his wife, who serves as trustee. The reporting person disclaims beneficial ownership of all shares held by the Sandra J. Dauch Gift Trust. 96,979 shares were transferred from the Dauch Annuity Trust 2004 to the Richard E. Dauch Trust, of which the reporting person is a beneficiary.
