(1) 965 previously owned shares having a market value of \$25.33 per share were delivered in payment of the option price of \$12.54 per share for 1,950 shares acquired pursuant to the exercise of an option granted under the 2002 Plan.

(2) 1,950 shares were acquired pursuant to the exercise of an Incentive Stock Option granted under the 2002 Plan.

(3) 1,936 previously owned shares having a market value of \$25.33 per share were delivered in payment of the option price of \$22.05 per share for 2,225 shares acquired pursuant to the exercise of an option granted under the 1997 Plan. In addition, 122 shares were withheld to pay Federal withholding taxes as permitted by the 1997 Plan and option grant.

In addition, 1,982 shares were withheld to pay Federal withholding taxes as permitted by the 2002 Plan and option grant.

8,801 previously owned shares having a market value of \$25.33 per share were delivered in payment of the option price of \$17.15 per share for 13,000 shares acquired pursuant to the exercise of an option granted under the 2005 Plan. In addition, 1,772 shares were withheld to pay Federal withholding taxes as permitted by the 2005 Plan and option grant.
