## Explanation of Responses:

  - (1) Represents Restricted Stock Units ("RSUs") awarded on September 4, 2008 under the Winn-Dixie Stores, Inc. Amended and Restated Equity Incentive Plan. The RSUs become vested, and certificates for shares of common stock become deliverable, in four equal annual installments beginning on the first anniversary of the date of grant. Each RSU represents a contingent right to receive one share of Winn-Dixie Stores, Inc. common stock. The Issuer's method of reporting RSU grants (which may be settled only in Issuer stock) has been revised to report such grants in Table I rather than as previously reported in Table II.
  - (2) The amount of securities owned balance includes 12,802 RSUs for which stock certificates will be issued upon vesting. Represents 21,629 RSUs that were granted on February 22, 2007, 7,138 of which vested on February 22, 2008 (a non-reportable event) and 14,491 of which have not yet vested. The grant of these RSUs was previously and timely reported in Table II. The Issuer's method of reporting RSU grants (which may be settled only in Issuer stock) has been revised to report such grants in Table I rather than as previously reported in Table II. The RSUs vest in three equal installments beginning on the first anniversary of the date of grant.
  - (3) The amount of securities owned balance includes 27,293 RSUs for which stock certificates will be issued upon vesting.
  - (4) The Option shall vest in equal annual installments over 4 years beginning with the first anniversary of the date of grant.
