- (1) This entry represents the number of shares of ViaSat, Inc. common stock withheld by the Issuer to satisfy the tax withholding obligation of the Reporting Person. - (3) Until vested, the restricted stock unit shall be subject to forfeiture in the event of termination of employment or service with the issuer.
