- (1) These sales were effected pursuant to a 10b5-1 plan adopted by the reporting person dated December 14, 2010 and modified by the reporting person on September 14, 2011. On September 7, 2012, the reporting person sold all shares authorized under the 10b5-1 plan resulting in its termination.
