(1) On February 13, 2012, the reporting person received performance restricted stock unit awards (the "PRSUs") to vest only upon satisfaction of certain performance criteria for fiscal year 2012. On March 1, 2013, the Issuer's Compensation Committee determined that all of the performance criteria associated with the PRSUs had been satisfied. Accordingly, 1/3 of the reported shares subject to the PRSUs shall vest on each of March 1, 2013, March 1, 2014 and March 1, 2015.
