- (1) These shares were acquired pursuant to a restricted stock unit award under the Company's 2014 Stock Option and Incentive Plan. Each restricted stock unit represents a contingent right to receive one share of the Company's Common Stock. The restricted stock units will vest over four years, with 25% vesting on July 1, 2019 and the remaining 75% vesting quarterly thereafter.
- (2) These shares were acquired pursuant to a restricted stock unit award under the Company's 2014 Stock Option and Incentive Plan. Each restricted stock unit represents a contingent right to receive one share of the Company's Common Stock. The restricted stock units will vest in equal quarterly installments vest over four years.
- (3) This stock option grant of 8,532 shares underlying the option will vest over four years, with 25% vesting on July 1, 2019 and the remaining 75% vesting quarterly thereafter.
