This Schedule 13G is being filed on behalf of (i) Mitchell P. Kopin, an individual who is a citizen of the United States of America (“**Mr. Kopin**”), (ii) Daniel B. Asher, an individual who is a citizen of the United States of America (“**Mr. Asher**”) and (iii) Intracoastal Capital LLC, a Delaware limited liability company (“**Intracoastal**” and together with Mr. Kopin and Mr. Asher, collectively the “**Reporting Persons**”).

The Reporting Persons have entered into a Joint Filing Agreement, a copy of which is filed with this Schedule 13G as **Exhibit 1**, pursuant to which the Reporting Persons have agreed to file this Schedule 13G jointly in accordance with the provisions of Rule 13d-1(k) of the Securities Exchange Act of 1934, as amended.

(a) and (b):

(i) Immediately following the execution of the Securities Purchase Agreement with the Issuer on December 15, 2017 (the “**SPA**”) (as disclosed in the Form 8-K filed by the Issuer with the Securities and Exchange Commission on December 15, 2017), each of the Reporting Persons may have been deemed to have beneficial ownership of 4,229,212 shares of Common Stock, which consisted of (i) 2,666,666 shares of Common Stock that was to be issued to Intracoastal at the closing of the transactions contemplated by the SPA and (ii) 1,562,546 share of Common Stock issuable upon exercise of a warrant that was to be issued to Intracoastal at the closing of the transactions contemplated by the SPA (the “**Intracoastal Warrant**”), and all such shares of Common Stock in the aggregate represent beneficial ownership of approximately 9.99% of the Common Stock, based on (1) 38,105,251 shares of Common Stock outstanding as of September 30, 2017 as reported by the Issuer, plus (2) 2,666,666 shares of Common Stock that was to be issued to Intracoastal at the closing of the transactions contemplated by the SPA and (3) 1,562,546 shares of Common Stock issuable upon exercise of the Intracoastal Warrant. The foregoing excludes 1,104,120 shares of Common Stock issuable upon exercise of the Intracoastal Warrant because the Intracoastal Warrant contains a blocker

provision under which the holder thereof does not have the right to exercise the Intracoastal Warrant to the extent that such exercise would result in beneficial ownership by the holder thereof, together with the holder's affiliates, and any other persons acting as a group together with the holder or any of the holder's affiliates, of more than 9.99% of the Common Stock. Without such blocker provision, each of the Reporting Persons may have been deemed to have beneficial ownership of 5,333,332 shares of Common Stock.

(ii) As of close of business on December 22, 2017, each of the Reporting Persons may have been deemed to have beneficial ownership of 2,666,666 shares of Common Stock issuable upon exercise of the Intracoastal Warrant, and all such shares of Common Stock in the aggregate represent beneficial ownership of approximately 4.8% of the Common Stock, based on (1) 38,105,251 shares of Common Stock outstanding as of September 30, 2017 as reported by the Issuer, plus (2) 14,683,333 shares of Common Stock issued at the closing of the transactions contemplated by the SPA and (3) 2,666,666 shares of Common Stock issuable upon exercise of the Intracoastal Warrant.
