ITEM 1. SECURITY AND ISSUER.

This Schedule 13D relates to the common stock, par value \$0.001 per share, of Optex Systems Holdings, Inc. (the “Issuer”), having its principal executive office at 1420 Presidential Drive, Richardson, TX 75081.

ITEM 2. IDENTITY AND BACKGROUND.

(a) The reporting person’s name is The Longview Fund L.P.

(b) The business address of the Reporting Person is 1325 Howard Avenue, Suite 217, Burlingame, CA 94010.

(c) The Reporting Person is principally engaged in the business of investing in equity, debt and other securities and assets.

(d) The Reporting Person has not, during the last five years, been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors).

(e) The Reporting Person has not, during the last five years, been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining further violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.

(f) The Reporting Person is organized in the State of California.

ITEM 3. SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION.

On September 18, 2017 through May 14, 2018, the Reporting Person sold an aggregate of 662,655 registered shares of the Issuer's Common Stock. On January 23, 2018 pursuant to the exercise of an option agreement entered into between the Reporting Person and another party, the Reporting Person sold 500,000 shares of Common Stock to the other party. On May 23, 2018, the Reporting Person sold 200,000 shares of Common Stock back to the Issuer.

ITEM 4. PURPOSE OF TRANSACTION.

ITEM 5. INTEREST IN SECURITIES OF THE ISSUER.

The Reporting Person owns 1,437,477 shares of the Issuer's common stock, representing 16.63% of the shares of common stock outstanding, based on a report from the Issuer's transfer agent as of May 21, 2018. The Reporting Person has sole voting and dispositive power over the common stock. Except as set forth in Item 3 above, the Reporting Person has not effected any transaction in the Issuer's common stock during the last 60 days.
