- (1) Shares acquired pursuant to conversion of Restricted Stock Units (RSUs) on a one-for-one basis. RSUs issued pursuant to issuer's Management Stock Purchase Plan under which executive may make an advance election to receive RSUs in lieu of specified % or dollar amount of annual incentive cash bonus under bonus plan application to the executive. RSUs are issued in whole units on the basis of a 33% discount from fair market value of the issuer's common stock on the date the underlying bonus is determined (\$9.45 in this case) and generally vest 3 years from the date of grant, at which time they convert into shares of common stock unless executive has previously elected a longer deferral period. The executive elected for a 4-year deferral period in this case. Transactions reported herein reflect the conversion of RSUs into shares and withholding of sufficient shares to pay taxes. Acquisition price reflected is based on a 33% discount of fair market value of issuer's stock to grant date.
- (2) Fair market value of shares, based on closing price of the issuer's stock on March 15, 2007 (last business day before shares vested) is \$34.71.
