(1) The Reporting Person was granted 16,760 shares of Deferred Common Stock under the 2013 Stock-Based Compensation Plan. 5,508 time-vested deferred shares vest over a three year period as follows: 1,836 time-vested deferred shares on April 3, 2018, 2019 and 2020, respectively. 5,744 performance-based deferred shares vest on April 3, 2020 based on the Company's Total Shareholder Return versus a defined peer group of companies, with the final number of performance-based vested shares varying from 0 to 200% of 5,744. 5,508 performance-based deferred shares vest on April 3, 2020 based on the Return on Invested Capital achieved by the Company compared to the ROIC target varying from 0 to 200% of 5,508.
