GOL Announces Proposal for Dividend Payment

São Paulo, March 7, 2005 GOL Linhas Aéreas Inteligentes (NYSE: GOL and Bovespa: GOLL4), Brazil's low-fare, low-cost airline, today announced that Company management has sent a proposal for distribution of dividends, after constitution of legal reserves, in the amount of R\$60.7 million (R\$0.64 per ADS or R\$0.32 per common and preferred share). The proposal, based on net income according to the Brazilian corporate law for the period ending on December 31, 2004, will be submitted for approval at the Annual Shareholders Meeting (ASM) to be held on April 11, 2005. The computation for GOL dividend payment is based upon the ten-month period in 2004 that GOL was existent. The net income for determination of proposed dividends was calculated by the equity method on GOL's principal wholly-owned subsidiary Gol Transportes Aéreos S.A. (GTA) as of March 12, 2004, base date of the corporate restructuring that resulted in the incorporation of GOL Linhas Aéreas Inteligentes S.A.

GTA's management will send a proposal for distribution of dividends, after constitution of legal reserves, in the amount of R\$76.2 million to be submitted for approval at the Annual Shareholders Meeting to be held on the same date as GOL's ASM. The difference between the dividend proposals of GTA and GOL will be retained by GOL and used for capital expenditures. If these proposals are approved by the respective ASMs, GOL shares will trade ex-dividend as of April 12, 2005, and dividends will be paid seven business days after their declaration at the Meeting (April 20, 2005).

GOL Linhas Aéreas Inteligentes, a low-cost, low-fare airline, is one of the most profitable and fastest growing airlines in the industry worldwide. GOL has a simplified fleet of Boeing 737s with a single-class of service. GOL has one of the youngest and most modern fleets in the industry with low maintenance, fuel and training costs, and high aircraft utilization and efficiency ratios. In addition, safe and reliable services, which stimulate GOL's brand recognition and customer satisfaction, allow GOL to have the best cost-benefit service in the market. GOL currently offers service to 39 major business and travel destinations in Brazil and Argentina. In 2005, GOL plans to grow by increasing frequencies in existing markets and adding service to additional markets in both Brazil and other high-traffic South American travel destinations.
