Dear Sirs,

The Board of Directors of this Bank, in a meeting held as of today, approved the proposal submitted by the Board of Executive Officers to pay to the Company's stockholders, pursuant to the Corporate By-laws and legal provisions, of interest on own capital related to the month of August/2005, **in the amount of R\$0.057000 per common stock and R\$0.062700 per preferred stock**, benefiting the stockholders registered in the Company's records on this date (August 1<sup>st</sup>, 2005).

The payment will be made on September 1<sup>st</sup>, 2005, at the net amount of **R\$0.048450 per common stock and R\$0.053295 per preferred stock**, after deduction of Withholding Income Tax of fifteen percent (15%), except for the legal entity stockholders that are exempt from such taxation, which will receive for the declared amount.

The respective Interests will be computed, net of Withholding Income Tax, in the calculation of the mandatory dividends for the year as provided in the Corporate By-Laws.

The Interests relating to the stocks under custody at CBLC - Brazilian Company and Depository Corporation will be paid to CBLC that will transfer to the stockholders through the depository Brokers.
