Payment of interest on capital

Rio de Janeiro, December 22nd, 2011 – Petróleo Brasileiro S.A. - Petrobras, informs that, the Board of Directors approved today the fourth advanced payment of interest on own capital (IOC), in accordance with Brazilian legislation.

The amount of R\$ 2,609 million to be paid, corresponding to a gross value of R\$ 0.20 per common and preferred shares, is being accrued in our Financial Statements on December 31st, 2011. Payment date will be no later than March 30th, 2012. The record date will be January 2nd, 2012, in Brazil.

The shares will be negotiated ex-interest on capital from the first business day after the record date.

This IOC restated at the Brazilian Interest Rate – SELIC, and the shareholders will be entitled to receive the payment restated by SELIC rate from December 31, 2011 to the effective payment date.
