- On January 31, 2007, the reporting person surrendered to the issuer options to purchase 9,057 shares of Class A common stock. The reporting person surrendered these options pursuant to the remediation plan announced by the issuer on December 20, 2006 in connection
- (1) with the issuer's review of its stock option granting practices and related accounting. Based on the January 31, 2007 closing sales price of the Class A common stock as reported by the New York Stock Exchange, the options surrendered had a value equal to approximately \$328,135.
  - (2) This option was granted pursuant to the 1997 Stock Option Plan, as amended, and became exercisable in 25% cumulative annual increments beginning on December 9, 2003.
