Reporting person will forfeit the Restricted Stock Unit at the end of the performance period if some or all of the units do not vest.
- (1) The Restricted Stock Units will vest over a period of approximately four years, provided certain performance criteria are met.
  - (2) The stock option vests at a rate of 25% per year commencing on September 10, 2016, and 25% on each subsequent anniversary date until 100% vested. The option shares are exercisable as soon as they have vested.
  - (3) The stock option vests at a rate of 25% per year commencing on September 11, 2015, and 25% on each subsequent anniversary date until 100% vested. The option shares are exercisable as soon as they have vested.
  - (4) The stock option vests at a rate of 25% per year commencing on September 11, 2015, and 25% on each subsequent anniversary date until 100% vested. The option shares are exercisable as soon as they have vested.
