Each RSU represents a right to receive one share of the Company's common stock upon settlement.
  - On March 15, 2010, the reporting person received a grant of 7,867 RSUs. On November 1, 2010 the Company amended its certificate of incorporation to effect a stock split in which each issued and outstanding share of Common Stock was converted into three shares of
- (2) Common Stock. Pursuant to the terms of the GMLTP, each issued and outstanding RSU was automatically converted into three RSUs, so that the employee was credited with a total of 23,601 RSUs, of which 50% were settled on March 15, 2013 and 25% were settled on November 7, 2013.
