(1) This transaction was executed in multiple trades at prices ranging from \$31.28921 to \$31.29143. The price reported reflects the weighted average purchase price. The reporting person hereby undertakes to provide to the SEC staff, the issuer or a security holder of the issuer, upon request, full information regarding the number of shares and prices at which the transactions were effected.

(2) As reported on Form 4 dated December 1, 2011 and filed on December 5, 2011, the reporting person received a grant of 3,481 Restricted Stock Units ("RSUs") on December 1, 2011. The RSUs were fully vested on the one year anniversary of the grant date and are settled on the third anniversary of the grant date. On December 1, 2014, 100% of these RSUs were settled, resulting in the issuance of 3,481 shares of Mattel, Inc. common stock.
