On December 10, 2014, in connection with the closing of the transactions contemplated by the Contribution Agreement, dated as of December 9, 2014, by and among the Issuer, Phillips 66 Partners GP LLC ("the General Partner"), and Phillips 66 Company ("P66 Company"), the Issuer acquired certain assets from P66 Company for consideration consisting of the issuance of 13,129 common units of the Issuer to P66 Company, the issuance of 268 general partner units of the Issuer to the General Partner and the assumption by the Issuer of a 5-year, \$7.56 million note payable to a subsidiary of P66 Company.

This Form 4 is filed jointly by Phillips 66 ("PSX") and P66 Company. P66 Company, a direct wholly owned subsidiary of PSX, owns all of the outstanding membership interests in the General Partner. Accordingly, the General Partner is an indirect wholly owned subsidiary of PSX. PSX may be deemed to indirectly own the securities of the Issuer directly held by the General Partner, but disclaims beneficial ownership except to the extent of its pecuniary interest therein. PSX may also be deemed to indirectly own the securities of the Issuer directly held by P66 Company, but disclaims beneficial ownership except to the extent of its pecuniary interest therein.
