David Hardcastle acquired 9,964,032 common shares of the Company through a Share Exchange Agreement for investment purposes, but may transfer or sell such shares as necessary and in accordance with applicable securities laws.

David Hardcastle has no plans or proposals which relate to or would result in:

- (a) The acquisition by any person of additional securities of the issuer, or the disposition of securities of the issuer.
- (b) An extraordinary corporate transaction, such as a merger, reorganization or liquidation, involving the issuer or any of its subsidiaries.
- (c) A sale or transfer of a material amount of assets of the issuer or any of its subsidiaries.
- (d) Any change in the present board of directors or management of the issuer, including any plans or proposals to change the number or term of directors or to fill any existing vacancies on the board.
- (e) Any material change in the present capitalization or dividend policy of the issuer.

Other than as described in Item 3 above, David Hardcastle has not effected any transaction in the shares of common stock of the Issuer in the past sixty days.

No person, other than David Hardcastle, is known to have the right to receive or the power to direct the receipt of dividends from, or the proceeds from the sale of, the 9,964,032 shares of common stock of the Issuer.
