Item 1. Security and Issuer

This Amendment No. 1 (this "Amendment") amends, as set forth below, the statement on Schedule 13D, dated September 2, 2015 and filed with the SEC on September 21, 2015 (the "Original Schedule 13D"), for Bank of America Corporation ("BAC"), Bank of America, N.A. ("BANA"), and Blue Ridge Investments, L.L.C. ("Blue Ridge") (collectively, the "Reporting Persons") with respect to the auction rate preferred shares ("ARP Shares") of AllianceBernstein National Municipal Income Fund, Inc. (the "Issuer").

This Amendment is being filed as a result of the sale to the Issuer of the ARP Shares of the Issuer (CUSIP No. 01864V) in connection with the tender, pursuant to a tender offer made by the issuer as described on Schedule TO, filed with the SEC on November 9, 2018 (the "Tender Offer"), in the amount of (x) 222 shares by BANA and (y) 1,548 shares by Blue Ridge.
