On April 22, 2010, the Board of Directors of the Registrant declared a 10.2% increase in the quarterly dividend rate, from \$0.49 per share to \$0.54 per share of Common Stock. At the new rate, the indicated dividend on an annual basis is \$2.16 per share compared to the previous rate of \$1.96 per share.
