(the “Company”) entered into an Underwriting Agreement for the sale of \$150,000,000 aggregate principal amount of its First Mortgage Bonds, 3.25% Series due December 1, 2027 (the “Bonds”). The sale of the Bonds closed on November 14, 2017. The Bonds were registered under the Securities Act of 1933, as amended, by means of the Company’s automatic shelf Registration Statement on Form S-3 (No. 333-213335-02), as amended by post-effective amendment no. 1 thereto (the “Registration Statement”), which such Registration Statement became effective upon such filing.
