- (1) On March 17, 2006, Mr. McCreery was granted Stock Appreciation Rights (SARs) with respect to a total of 17,000 shares of common stock. The grant price for the SARs is \$28.77 per share of common stock. The SARs will vest at the rate of 25% per year on the first four anniversary dates from the date of grant. They will expire on the earlier of (i) sixty days after Mr. McCreery is no longer an officer of Stage Stores Inc. or (ii) seven years from the date of grant.
