- (1) Settlement of Performance Rights which were awarded by the Board's Compensation Committee on 2/24/10 pursuant to the Nordstrom, Inc. 2004 Equity Incentive Plan. The Performance Rights vested on 2/27/13, based upon the Compensation Committee's determination that the applicable performance criteria had been met as of 2/2/13. 2,589.75 shares vested of which 108 shares were withheld for taxes. The reporting party elected to defer the balance of 2,481.75 shares to the Executive Deferred Compensation Plan.
