Net income for the six month period ended June 30, 2014 is anticipated to increase as compared with the same period in 2013. In 2013 we reported a net income of \$1,569,000; however we anticipate that net income for the period ended June 30, 2014 will be in the range of approximately \$2,200,000 - \$2,400,000, or \$0.32 - \$0.35 per share.

Total revenues for the six months ended June 30, 2014, are expected to increase approximately \$1,100,000 for 2014 over that reported for the same period of 2013. Total expenses for the six months ended June 30, 2014, are expected to increase by approximately \$500,000 over that reported for the same period in 2013.
