Shares of Company common stock will be issued in substantially equal increments on the first, second and third anniversaries of the date of grant, in each case subject to tax withholding requirements.

The options vest with respect to one-fourth (1/4) of the total number of shares of common stock underlying the stock options on each of the first four anniversaries of the date of grant.
