The Registrant is unable to file the subject report within the prescribed time period because the Registrant is currently in the process of internal restructurings, redeveloping the Company's business plan and a work-out of its debt, which may be completed at or just subsequent to the due date of the Registrant's Form 10-K. The Company's workforce has been reduced. Due to the internal and debt restructurings and the reduced staff availability, the 10-K cannot be filed on time without unreasonable effort and expense. The Company anticipates that it will have a net loss of approximately \$13,025,000 for the year ended July 31, 2001, compared to \$7,602,000 for the year ended July 31, 2000. The increase in net loss is primarily due to a restructuring designed to refocus resources from the Company's communication products, which generate negative cash margins, to the Company's core catalog products, which contribute greater cash margins, in order to reach sustainable cash generation and earnings. During the quarter ended July 31, 2001, the Company incurred non-cash amortization charges of \$7,333,000 for the write-off of impaired assets related to our network platform and communication software and \$433,000 in accrued restructuring expense

related to severance and future minimum lease payments. As of October 25, 2001, the Company had reduced its number of full-time equivalents to 101 from 131 prior to the restructuring.
