Pursuant to the Merger Agreement, on October 6, 2017, these shares were cancelled and converted into the right to receive 40,614 class A ordinary shares of Parent and a cash payment for fractional shares pursuant to the Merger Agreement.
- (2) Pursuant to the Merger Agreement, these Performance-Based Restricted Stock Units were canceled and converted into the right to receive 174,716 class A ordinary shares of Parent and a cash payment for fractional shares pursuant to the Merger Agreement.
