(b) As previously reported, on June 30, 2007 Henry G. Nanz, Frank E. Weismiller, Jr. and William S. Gehring retired as directors from the Boards of Directors of United Community Bancorp (the "Company"), the holding company of United Community Bank (the "Bank") and United Community MHC. Messrs. Nanz, Weismiller and Gehring will each serve as a director emeritus of the Company and the Bank effective upon their respective retirements.

FISCAL YEAR.

In connection with the previously announced retirement of Henry G. Nanz, Frank E. Weismiller, Jr. and William S. Gehring, the Board of Directors of the Company amended Article III Section 2 of the Company's Bylaws to decrease the number of directors from twelve to nine effective July 1, 2007.
